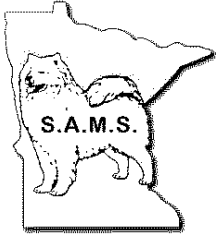

Our auction last year was lots of fun for the donors, as well as, the Bidders. Through the generosity of our sammy lovers - the foundation was able to raise over \$6000 for future research.

We are currently squirreling funds and in negotiations to establish a DNA bank for Samoyeds that will be the first of its kind in dogs- a cheek swab and blood DNA bank with complete security and data sorting abilities - and a possible option of frozen semen and/or tissue storage. The reason we need a bank is that researchers are not generally interested in using our breed as the focus of their investigation without studies we can't get answers. The establishment of a DNA bank in Samoyeds would get us into a research investigation as the focus breed because we have what they want - a broad cross section of readily available DNA - normal dogs, those who are carriers, those who are relatives, those who are affected. Such a cross section would make researchers willing to use the Samoyed as a major focus breed in their investigation because they have every thing they need to do a sound research study.

Actually, from speaking with researchers the message they gave me is-build a bank and many researchers will come knocking on our doors.

Therefore, we are running a second e-bay auction to raise the funds necessary to create a state of the art bank.

Lessons I've learned or the most expensive pair of pantyhose

Kelly got her stitches out today. She gets to go out in the yard again and play with her friends. Every time I look at her I am filled with joy that she is still with me. She made an incredible journey over the past two weeks and I'd like to think that I got something more out of it than the world's most expensive pair of pantyhose. Bob Hupp recently mentioned his \$2500 sock... lets just say I envy him :) What did I learn from Kelly's experience?

- 1) Pantyhose are Deadly to dogs. Yes Deadly with a capital D.** There are few things they can ingest that are worse. In Kelly's case one leg stayed in her tummy acting as an "anchor" for the other leg which tried to travel down her intestines. Think of a drawstring on the waistband of a pair of pants when you gather it up. That's what happened to her intestines. Once they were gathered up, the pantyhose began to saw back and forth cutting thru the intestinal wall. She had 7 perforations in her intestine, some which did not even show up until after the pantyhose were removed, basically spots weak at the time of the first surgery but not perforated all the way thru. Do yourselves a favor and, whatever else you might leave lying around for your dog to get into, DO NOT EVER leave pantyhose anywhere the dogs can find them.
- 2) If you ever suspect a blockage in your dog do not let your vet treat the dog as if it "might" be an upset tummy.** X-ray the dog immediately. In Kelly's case the first x-ray showed nothing unusual in her intestines but there was a mass in her tummy. My vet assumed it was food. He treated her as if she had an upset tummy and encouraged me to feed her when she came home. Knowing Kelly and her trash eating tendencies, I should have suspected a blockage before anything else and should have insisted on fasting her with another x-ray 12 hours after the first. We then would have seen the mass still in her tummy and would have known it was not food. At that point they might have been able to use a scope into her tummy to get it out, or at worse, done surgery to remove it from her stomach without getting her intestines involved.
- 3) If your dog is not acting what you think should be normal for them after surgery - at a point where they should be recovering - ask the doctor to do an abdominal tap.** This is a simple and inexpensive (\$35) procedure where they remove fluid from the abdominal cavity and examine it. If there is *any* intestinal leakage post surgery it will show up. If we had done one on Kelly after the first surgery we would have known something was wrong before she got home. After the 3rd surgery Kelly's temp stayed at 101.2 - 101.5 for several days. The 3rd day it jumped to 102.5. Even though still considered normal, the specialist immediately did an abdominal tap.... And we stopped worrying as it was 100% normal. The slight temperature rise was just her body trying to heal.
- 4) Trust your instincts about your dog.** As the specialist who ultimately saved Kelly's life said... "Dogs are great liars and Kelly is better than most". And the doctor who did the first surgery also told me she learned a lesson from Kelly... not to always trust the clinical indications that a dog is fine. Kelly tried (with her panic attacks) to tell us something was wrong and no one listened because all the clinical signs (temp, blood pressure, blood work, heart rate) were normal. Prior to the 2nd surgery, the emergency room vet said she could not believe Kelly's heart rate was 100% normal, given how much pain she should have been in. She also thought Kelly looked "great" ... but I knew the Kelly that had been home for less then 24 hours was not the Kelly she should have been. In the future I will trust my dog.... Those panic attacks were NOT normal for a healthy happy Kelly... even given the trauma she'd been thru.
- 5) If your dog is ever seriously ill and on supportive care (fluids, pain meds, etc.) and has an extended hospital stay... INSIST that all treatment (other than long term stuff such as antibiotics) be removed for at least 12 hours before you agree to take the dog home.** Again, if we had done this with Kelly after the first surgery we would have known she was not okay. They basically took her off everything while I was there waiting to pick her up. By the time we got home (3 hours later) she was already showing signs that something was wrong.... She was lethargic, wouldn't eat and her temp was slightly elevated. When they released her the second time I insisted (and the specialist agreed) that she be off the fluids and pain med before they did a final evaluation to release her.

6) Dog can receive one blood transfusion of any blood type from any dog. But once they receive that one transfusion, if they ever require blood again it MUST be the same type as their own. I don't really understand this, (Deb F. can you shed any light?) but when I asked about the plasma Kelly was given this is what I was told. In her case she received plasma, not blood, so is still "safe" should she ever need blood. But if you have a dog that has received a transfusion and you don't know if the type was a match BE SURE to tell the doctor about it should they ever need blood again. Otherwise the transfusion can kill them.

7) There is credit card called CareCredit. Many vets take it. It is a credit card used specifically for health care related costs. And I even found out it can be used to pay for some human stuff as well. We now have a shiny new CareCredit card in our possession "just in case" we ever have an emergency and don't have the cash to pay for it. Do your dogs a favor and, if you can, get a CareCredit card. I don't believe in or use credit cards but I'll treasure this one. Even if you have a "shopping problem" this is one to have..after all you can't use it for anything but health care.. So it's not a "real" credit card :)

8) And ... in trying to look at the silver lining in all that happened.... Back in January I set a goal to lose 34 lbs. By early June I had lost 28 lbs and hit a plateau. Didn't budge for 2 months. Kelly helped me lose the last 7 pounds :)
